## **Invitation: 2nd Seminar International Tribunal for Life: Life on Trial Berlin-Auschwitz, September 16-23, 2011**

### **Neurenberg trials**

The thought of a possible International Tribunal for Life came up during our international conference Abortion & Armageddon and our visit to the Auschwitz concentration camp in Poland last September 11-18, 2010. Auschwitz reminds us of the Neurenberg trials after World War II. Nazi's were charged and found guilty by their crimes and received a death penalty or other punishment. Today, like Neurenberg, The Hague is appointed by the United Nations to host International trials. Worldwide people who (have) committed crimes to humanity are being brought in and charged with (mass) murder in a certain degree. International courts, judges, lawyers, research; every effort is made to let justice and righteousness have its way.

### **Crimes to humanity**

Mass murder, crimes to humanity. How about justice and righteousness for the crimes that take place in the mothers womb? Generations of unborn babies are being killed brutally. Aggressive violence takes place behind closed doors. Houses of death are still operating today. It seems like nothing has changed since World War II. Even the Universal Human Rights Declaration, embodied by Unicef does not stand up for the unborn baby. How about all the suffering mothers and fathers, who regret their so called choice. But there is no point of return. What a tragedy takes place in families, societies and nations. Worldwide about 50 million unborn babies a year are not allowed to live!

### **The Hague, international trials**
